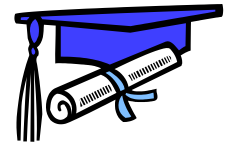
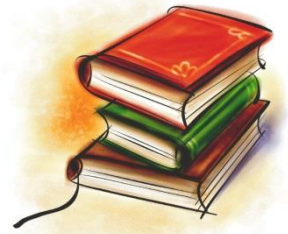

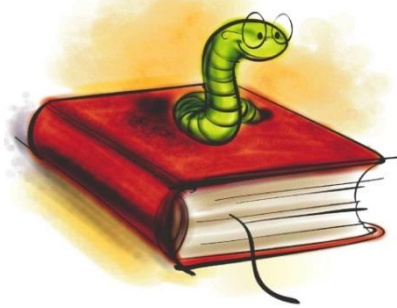

Documents Needed for Financial Aid Assistance



Need **2017** information for the **2019– 2020 school year.** (Summer 2020)
Need **2018** information for the **2020– 2021 school year.** (Fall 2020-Summer 2021)

When applying for FAFSA - financial aid you will need send EOC copies of:

- **Your 2017 and/or 2018 Federal Income Tax Return and W2s (signed) and**
- If married, your spouse’s signed 2017 and/or 2018 Income Tax Return.
- Your parents signed 2017 and/or 2018 Income Tax Return and W2s if the answer is “no” to all these questions:
 - You were born before 1/1/1996? (2019-2020 FAFSA)
 - You were born before 1/1/1997? (2020-2021 FAFSA)
 - Are you married?
 - Are you working on a Master’s or Doctorate degree?
 - Are you a veteran of the US armed forces?
 - Are you currently serving active duty in the US armed forces?
 - Do you have children who receive **51%** of their financial support from you?
 - Do you have dependents who receive **51%** of their financial support from you?
 - Are both your parents deceased or were you a ward of the court or in foster care? *
 - Did someone other than your parents have legal guardianship of you? *
 - Are you or were you an emancipated minor as determined by a court? *

If any of the following apply to you or your household you will need:

- **Child Support**
 - An annual statement of the total amount received in 2017 and/or 2018.
 - An annual statement of the total amount paid in 2017 and/or 2018.
- **Welfare Benefits**
 - An annual statement of the total benefits received in 2017 and/or 2018.
- **Social Security**
 - An annual statement of the total amount received in 2017 and/or 2018.
 - Bring a statement for each person in the household who received benefits.
- * **Legal Guardianship, Foster Care, or an Emancipated Minor**
 - Bring signed copies of the legal court documents for proof of legal guardianship, foster care, or an emancipated minor.

(Have the person who received the benefits sign the documents.)
